INVESTMENT TARGET

The Sub-Fund pursues a medium- to long-term strategy to increase asset value by investing primarily in equities listed on equity and/or other regulated, regularly operating, recognized and open markets, in bonds and money market instruments, and in UCITS and/or other UCIs, with a focus on issuers and/or instruments that respect ethical finance values within the financial markets, that make choices that are strongly based on socially responsible investments, and that are focused on good corporate governance and on safeguarding people, the environment and life.

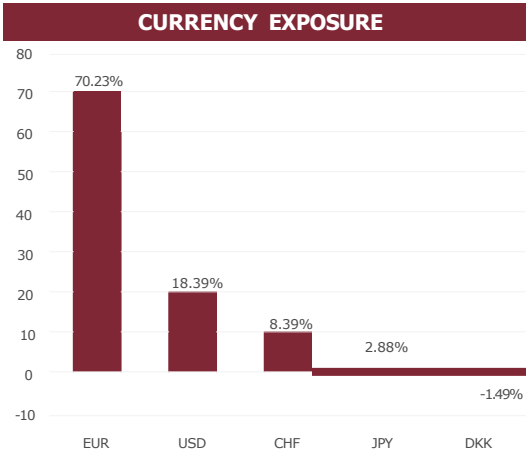
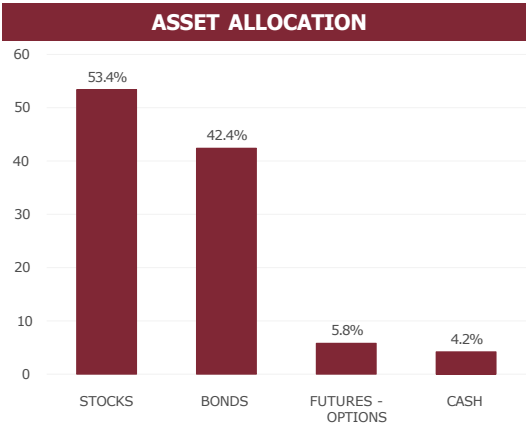
MANAGER COMMENT

September was a positive month for risk assets, both in equities and bonds. On the other hand, so-called risk-free assets underperformed, closing the month essentially unchanged. The MSCI World returned 2.61% in euro terms, with a marked outperformance of US equities. The Fed confirmed a dovish stance, reaffirming what was stated in August. The fund is currently, including derivatives exposure, 58% in equities and 42.5% in bonds. The absence of rates is currently structural and, given the reduced volatility, no volatility selling strategy has been adopted, which contributed about 55bps in the last 2 months. We remain positive on risk, especially in light of the extremely low Q3 expectations in the US. Spreads are tight, but the alternative, risk-free assets, are still a source of unremunerated volatility in our opinion, also given the significant levels on the 30-year OAT and Japanese bonds. On the currency side, we are still partially hedged with a net exposure of 18%, with about 30% of hedging and an 8.5% long position in the Swiss franc.

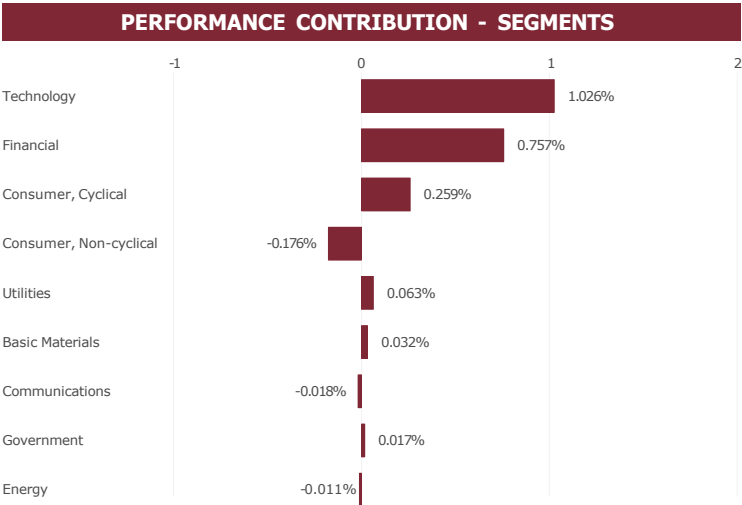
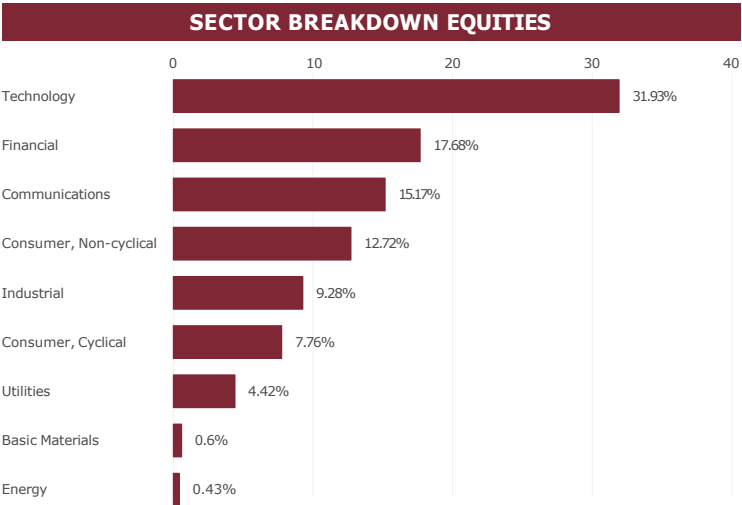
Country Allocation
