## What is this product?

### Type

Valori SICAV is an undertaking for collective investment in transferable securities (UCITS) incorporated in the legal form of an investment company with variable capital (SICAV) under Part I of the Luxembourg 2010 Law on undertakings for collective investment.

### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

The Sub-Fund invests with a medium to long-term strategy for increasing the value of its assets.

The Sub Fund's net assets will be invested in equities of global issuers and/or UCITS and/or other UCIs, incl. ETFs, pursuing an equity-type of strategy. The Sub fund will regularly invest directly and indirectly between 10% and 70% in equity and/or other equity-type of transferable securities. The remaining part will be invested directly and indirectly through other UCITS and/or other UCIs, incl. ETFs, in FI instruments issued by corporates, governments and sovereign/supranational entities essentially in OECD countries without any limitation in terms of sector allocation. Up to 35% in debt securities unrated and/or graded below BBB- by S&P's Rating Agency or equivalent. The Sub-Fund will not invest in distressed or defaulted securities. The Sub-Fund will not invest directly in ABS, MBS or CoCos. Although this is currently not foreseen, the Sub-Fund's exposure may, depending on the market opportunities, also, to a max. of 30%, include investment positions with exposure to EM and Chinese exposure listed in other countries such as Hong Kong including Chinese A and B shares traded via Shanghai-Hong Kong Stock Connect or Shenzhen-Hong Kong Stock Connect. For up to 10%, through investment in transferable securities without embedded derivative (i.e. ETC) and UCITS and/or other eligible UCIs, the Sub-Fund may indirectly be exposed to commodities.

The Sub-Fund may enter into securities lending transactions. The Sub-Fund will not make use of other securities financing transactions. The sub-fund is actively managed and does not refer to any benchmark. Sustainability risks are not systematically integrated on the basis of the investment strategy and the type of underlying investments.

The return of the fund depends primarily on the development of capital markets. To varying degrees, it will be a function of the following components: equity market development and dividend payments, development of interest rates, creditworthiness of the entities issuing the invested instruments and interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist.

Income of this share class is reinvested. The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

### Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

## What happens if UBS Asset Management (Europe) S.A. is unable to pay out?

Losses are not covered by an investor compensation or guarantee scheme. Furthermore, with respect to UBS Europe SE, Luxembourg Branch as depositary of the Fund, which is responsible for the safekeeping of the assets of the Fund (the "Depositary"), there is a potential default risk if the assets of the Fund held with the Depositary are lost. However, such default risk is limited as the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary is liable to the Fund or to the investors of the Fund for the loss by the Depositary or one of its delegates of a financial instrument held in custody unless the Depositary is able to prove that the loss has arisen as a result of an external event beyond its reasonable control.

## What are the costs?

### Costs over time
